The following items will not be accepted:

- manufactured and imported goods
- commercial jewelry
- catalog products
- items made from kits
- consigned goods

We reserve the right to ask exhibitors to remove unsatisfactory items.

**Jury** | The 2010 jury will be composed of independent, community artists and MAC staff.

**Sales Tax** | State law requires exhibitors to have a Minnesota sales tax number.

**Liability Insurance** | Exhibitors are responsible for having liability insurance. MacRostie Art Center is not responsible for any loss, claims, or liability for exhibitors.

**Parking** | After unloading, exhibitors will move vehicles to a designated space. Selling from vehicles will not be allowed.

**Cancellation & Refund Policy** | No refunds will be made after booths are assigned and reservations confirmed (May 5, 2010). The entry fee also will not be refunded in the case of misrepresentation of the artist's work. Refunds will not be given for inclement weather. The event will take place rain or shine.
